Living Trust Buy-sell Agreements Probate Estate Taxation & the Business Owner

From the North:

If approaching the city of Bend from the North or Northwest, take the parkway south though the city of Bend. Take the last exit from the parkway, before it returns to Hwy 97 So. This will be a left exit from the parkway at "Hwy 97 Business" exit. It will take you off the parkway and you will be going North on 3rd St. (Business Hwy. 97). The first signal is Murphy Rd. Turn right (east) and continue 3 blocks to Country Club Dr. Turn right and we are located on the right side of the street across from the fire station.

From the South:

Traveling north on Hwy 97. Do no get on the parkway. Take the Business 97 exit onto3rd St. Continue to the stop light at Murphy Rd. Turn right (east) and continue 3 blocks to Country Club Dr. Turn right and we are located on the right side of the street across from the fire station.
